- NIT No.-140/PR/NBPDCL/2013 was floated for procurement of 63 KVA 3 star rating 11/0.433 KV Aluminum Wound Distribution Transformers.
- Purchase order No. 47 dated 07.08.13 was issued against above NIT to M/s Prag Electricals Pvt. Ltd., Industrial Area, Bamunimaidan, Guwahati (Assam) for supply of 480 nos, 63 KVA 3 star rating 11/0.433 KV Aluminum Wound Distribution Transformers within delivery Schedule of 03(Three) Months from the date of issue of Purchase Order:-

3. The Firm has neither executed Agreement nor offered any quantity of Materials for inspection till date.
4. Three Defaulter Notices including action for termination of contract and blacklisting /Debarment had been served to firm vide this office Letter No.-784 dt.01.10.13, Letter No-929 dt. 24.10.13 and Letter No-.1193 dt.12.12.13.
5. In response to Letter No-.1193 dt.12.12.13 the Firm intimated to this office vide their Letter No.1/2013-14/966 dated 16.12.13, that Raw materials and other inputs were to be procured from outside states. After getting the Purchase order, they placed order for load Management, which was placed to the party in Hyderabad. Unfortunately they were yet to receive that. Also there has been delay in receipt of Raw material & other inputs due to prevailing circumstance. Delay is also attributable to the insurgency and other local problem in the state.
6. The firm was again requested vide this office letter no. - 47 dated-09.01.2014 regarding delivery schedule period for offer of 480 nos., 63 KVA Distribution Transformer as per above Purchase Order but material has not been offered till date.

### ORDER

In view of the facts explained above, North Bihar Power Distribution Company Ltd takes following decision:-

- (1) Cancellation of Purchase order No. 47 dated 07.08.13
- (2) Debarment M/s Prag Electricals Pvt. Ltd., Industrial Area, Bamunimaidan, Guwahati-781021 (Assam) from taking part in future tender and other business dealings with North Bihar Power Distribution Company Ltd. for a period of 02 (two) years from the date of issuance of this letter.

This order shall come into force with immediate effects.
