- 4- In general cases, prior to completion of contract period, the contract can be terminated by giving one month notice or one month remuneration from either side.
- 5- In the interest of the company Sri Prasad may be transferred any where within the jurisdiction of North Bihar Power Distribution Company Limited.
- 6- Only casual leave will be admissible. No other leave shall be admissible.
- 7- No other facilities shall be admissible to Sri Prasad as admissible to the regular employee of North Bihar Power Distribution Company Limited, Patna.
- 8- No TA/DA will be admissible for joining to the post.
